The Ohioana collection is comprised of the literary work of Ohio writers and books about Ohio. It contains more than 100,000 items including 50,000

books, 25,000 biographical files, and 8,000 pieces of sheet music, Ohio periodicals, scrapbooks on various topics, manuscripts, and subject files. Ohioana's mission is to recognize and encourage the creative accomplishments of Ohioans, preserve and expand a permanent archive of books, sheet music, manuscripts, and other materials by Ohioans and about Ohio, and disseminate information about the work of Ohio writers, musicians, and other artists to researchers, schools, and the general public. The Ohioana collection is the basis on which all of Ohioana's programming is based.

Part X - FIN 48 Footnote

Ohioana is exempt from Federal income taxes under Section 501 (c) (3) of the Internal Revenue Code.

Ohioana follows FASB guidance on accounting for uncertainty in income taxes, which addresses the determination of whether tax benefits claimed or expected to be claimed on a tax return should be recorded in the financial statements. Under this guidance, Ohioana may recognize the tax benefit from an uncertain tax position only if it is more likely than not that the tax position will be sustained on examination by taxing authorities, based on the technical merits of the position. Examples of tax positions include the tax-exempt status of Ohioana, and various positions related to the potential sources of unrelated business taxable income (UBIT). The tax benefits recognized in the financial statements from such a position are measured based on the largest benefit that has a greater than 50 percent likelihood of being realized upon ultimate settlement. The guidance on accounting for uncertainty in income taxes also addresses de-recognition,

classification, interest and penalties on income taxes, and accounting in interim periods. At June 30, 2018, there were no material unrecognized tax benefits identified or recorded as liabilities.
